- 6. This school is registered with 24221528505 U dise number.
- 7. School has filed this proposal on 30-10-2023 to determine fees for the year 2024 25, 2025 26 & 2026 27. We have gone through the proposal and determined the provisional fees on 20/09/2024. The said order was collected by the school. Being aggrieved by the said order, school has submitted its objection vide a letter dated 03/10/2024. On 26/08/2025, this committee issued a notice to the school for submission of certain document and physical hearing to the school.
- 8. On 04/09/2025, Mr. Pranav Gonawala, Accountant of the school appeared before the committee and hearing was conducted. During hearing, this Committee asked more information and certain documents and therefore the hearing was adjourned. On 16/09/2025, this committee again issued a notice to school to submit the information and documents asked during the earlier hearing and also for physical hearing. On 25/09/2025, the school submitted a letter stating that Due to illness, the legal advisor and Head of Accounts and Financed Department is on leave and therefore school requested to reschedule the hearing after 10-15 days. On 06/10/2025, this committee issued thired notice to the school for physical hearing.
- 9. On 08/10/2025, Mr. Pranav Gonawala, Accountant of the school appeared before the committee and hearing was conducted. During hearing, it is

submitted by Mr. Pranav that school is affiliated with CBSE Board. After perusing the documents submitted along with the proposal file, it appears that strength of the students was 1879 in year 2024-25. Mr. Pranav also said that school had spent Rs. 18,74,46,447/- towards salary including PF, Gratuity, leave encashment and medical Insurance etc, in year 2024-25. To verify this amount, this committee asked to submit salary certificate issued by Bank and therefore school submits the salary certificate issued by HDFC bank of Rs. 18,74,46,447/-. It is also submitted by authorized person that school had paid Rs. 10,80,000/-towards Rent in year 2024-25. This committee had gone through the provisional Income expenditure Statement, submitted by the school, it appears that the school has projected a loss of Rs. 4,73,42,391/- in year 2024-25. Considering the strength of the students, inflation rate and the accounts detail submitted by the school and requests made by authorized persons of the school, this committee determine Final fees as under:
